Liability Release

In consideration of renting and operating a mountain bike from Bike the Coast, I hereby release Bike The Coast its members, agents, employees, landlord, successors or assigns (hereinafter referred to as "Released Parties"), from any and all liability, claims demands, actions, and causes of action whatsoever, whether foreseen or unforeseen, arising out of or related in any way to my renting and operating a mountain bike from and together with Bike the Coast that may result in injury, death or property damage or loss or other damages to me or my family, estate, heirs, or assigns, and further to save and hold harmless the Released Parties from all liabilities whatsoever for personal injury, property damage or loss or wrongful death caused by its negligence.

I understand that mountain biking is dangerous and may become more hazardous or dangerous on difficult tours, that the risk of injury from the operation of a mountain bike is significant, including the potential for serious bodily injury, paralysis and death; that I am aware of all the risks and hazards inherent with my operating a mountain bike on the tours with Bike the Coast and hereby voluntarily assume all risk of loss, damage and injury, including death, that may be sustained by be or any property of mine while on tour with Bike the Coast. This release shall be binding upon my family, estate, heirs, or assigns.

In signing the foregoing Liability Release, I acknowledge and represent:

- That I have read the foregoing Liability Release, understand it, and sign it voluntarily;
- b) That I am at least 1.4 meters (4 ft 8 in) tall;
- c) That I am not pregnant;
- That I have not consumed alcohol or drugs, which may affect my ability to ride a mountain bike in a safe manner;
- e) That I do not suffer from a heart condition, high blood pressure or other medical condition which may be aggravated by my operating a mountain bike;
- f) That I will wear a helmet while riding the mountain bike;
- g) That I will obey all the rules and regulations of the Kenyan traffic code;
- h) That I will closely observe and follow the instructions of all tour guides;
- That this release is continuing and shall remain in effect every time I use any service of Bike the Coast;
- j) That if I am under 18 I must have my parent or legal guardian sign this form.

In signing this Liability Release I furthermore acknowledge and represent:

That I have to pay for up to KES 2'000/= in damage done to the mountain bike which I am riding. This treated as a no fault process, so if my mountain bike is damaged due to accident I didn't cause, I am still liable for up the KES 2'000/= damage limit on my mountain bike.
